**Title: Referendum on Ordinance 2006-O-01 that rezoned 30 acres to Residential Planned Unit Development.**

**Petition Summary:** As set forth by the Charter, the City Council shall be required to reconsider adopted Ordinance No. 2006-O-01 which rezoned approximately 30 acres located east of U.S. Highway 1 and north of Jones Fish Camp Road to city residential planned unit development. If the City Council fails to repeal such ordinance so reconsidered, the voters shall approve or reject Ordinance No. 2006-O-01 at a city election. A copy of the ordinance is attached hereto.
